## 1) A Bill to Limit the NSA

1. Section 1: The National Security Agency (NSA) will hereby be limited to observing

5. Section 3: The Department of Justice will oversee this bill. Any information on non

6. Convicted United States citizen(s) will be strictly prohibited and will be deleted from

7. Federal databases outside of essential information such as birth certificates, and any

**8.** Licenses given by a State or the Federal Government.

9. A: Any NSA staff that are not cooperative with this bill and its laws after passage

- **10.** Will be fined \$5000 for the first offense.
- 11. B: The second offense will result in removal from his/her position with the NSA
- **12.** As well as an additional fine of \$2000.
- 13. Section 4: This bill will take place immediately after passage.

14. Section 5: Any laws in conflict with this bill are hereby declared null and void.

11. the Puerto Rican people would want to either become a state or remain a territory;

12. and be it

13. FURTHER RESOLVED, That if the referendum passes, that the United States

14. Move forward with legislation intended to make Puerto Rico the next state.

- 8. Glass-Steagall did the exact opposite; and
- 9. WHEREAS, The financial meltdown of 2008 further proved the need for more
- 10. Regulation in the banking system; now, therefore, be it

11. RESOLVED, By the Student Congress here assembled that the United States moves

- 12. Forward with legislation to repeal the Gramm-Leach-Bliley Act of 1999 and
- 13. Reinstating the Glass-Steagall Act of 1933.

- 5. Over these prisons through buying out the contracts currently possessed by third party
- 6. Private companies.

- 7. SECTION 3: The Department of Justice shall oversee the enforcement of this bill.
- 8. SECTION 4: This bill shall go into effect on January 1, 2017.
- 9. SECTION 5: All laws in conflict with this bill are hereby declared null and void.

- 6. **D:** Military operations against Palestinians cease for a period of three years.
- 7. E: The Gaza blockade is lifted;
- 8. F: The Israeli settlements in the West Bank are vacated.
- 9. G: Construction projects on new settlements in the West Bank are ended; and
- 10. H: Israel recognizes the Palestinian nation, as set forth by the United Nations, as a
- **11.** Sovereign state.
- 12. SECTION 2: The Department of State and the Department of Defense shall oversee
- **13.** This bill.
- 14. SECTION 3: This bill shall go into effect on January 1, 2016.
- 15. SECTION 4: All laws in conflict with this bill are hereby declared null and void.

11. That the Congress here assembled authorize military action against ISIL.

## 9) The American Property Rights Act of 2015

### **1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:**

- 2. SECTION 1. All asset forfeiture practices carried out by the United States
- 3. Department of Justice or United States federal agencies working in direct cooperation
- 4. With the United States Department of Justice that require no more proof than a
- 5. Preponderance of the evidence to proceed in seizing property or result in *in rem*
- 6. Actions are hereby abolished.
- 7. SECTION 2. An "asset forfeiture practice" shall be defined as an action by which a
- 8. Governmental agency deprives a citizen of his or her property in connection to a
- 9. Violation of the law.

10. SECTION 3. A "preponderance of the evidence" shall be defined as the conclusion

11. That a proposition seems more probably true than false.

12. SECTION 4. An "*in rem* action" shall be defined as a legal action brought directly
13. Against a piece of property rather than against a citizen in which the property is the
14. Defendant and no criminal charges against the owner of the aforementioned property
15. Are necessary.

16. SECTION 5. The Department of Justice will oversee the implementation of this17. Legislation.

18. SECTION 6. This law shall take effect ninety days after its passage.

19. SECTION 7 All laws in conflict with this legislation are hereby declared null

**20.** And void.
