1) A Bill to Mandate Electronic Textbooks

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION** 1. The United States Government shall mandate that all public schools
- 2. shall be equipped with electronic textbooks for each course, if available.
- **3. SECTION 2.** Paper textbooks shall still be permitted in the schools.
- **4. SECTION 3**. The Department of Technology shall execute this legislation.
- 5. SECTION 4. All schools or school departments who do not comply with giving their
- **6.** students textbooks shall be fined \$250 for every course that a student is not provided
- 7. with textbook.
- **8. SECTION 5.** This law shall take effect on January 1, 2018.
- **9. SECTION 6.** All laws in conflict with this legislation are hereby declared null and void. *Introduced for Congressional Debate by SHS, Maine District*

2) A Bill to Cease the Production of One Cent Pieces and Five Cent Pieces BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. The "cent" or "one cent piece" and "nickel" or "five-cent piece" shall
- **2.** hereby no longer be minted.
- 3. SECTION 2. Minting shall be defined as the production of new "cents" or "one cent
- 4. pieces".
- **5. SECTION 3.** All current "cents" or "one cent pieces" and "nickels" or "five-cent
- **6.** pieces" shall remain in circulation and shall remain a valid form of U.S. currency.
- 7. SECTION 4. The United States Mint shall oversee the implementation of this bill
- **8. SECTION 5.** This bill shall go into effect 30 days after passage.

9. SECTION 6. All laws in conflict with this legislation are hereby declared null and void.

3) A Bill to Have a More Complete Analysis of Transgender People in the Military

- 1. WHEREAS the NHS (National Health Service) and other health organizations have
- 2. classified gender dysphoria (gender identity disorder) as a mental illness.
- 3. WHEREAS the military has to perform analyses and background checks on other mental
- 4. illnesses such as; depression, bipolar disorder, anxiety, PTSD (Post Traumatic Stress
- **5.** Disorder), schizophrenia, etc.
- 6. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 7. SECTION 1. All transgender people must have a analyzation done for gender dysphoria and
- **8.** background check performed in order to be recruited into the military.
- 9. SECTION 2. Transgender people includes both transgender males and transgender
- 10. females.
- 11. SECTION 3. Questions regarding the gender dysphoria analysis must be that from the
- **12.** medical questionnaire for transgender people.
- 13. SECTION 4. Transgender people wishing to join the military must either meet or exceed
- **14.** The physical training of the gender they are wishing to transition to.
- 15. SECTION 5. In order to receive transgender treatment through the military (hormones,
- **16.** chest surgery, genital surgery, etc.) you must show transgender (Gender Identity Disorder)
- **17.** diagnoses papers.
- **18. SECTION 6.** The U.S military shall oversee the implementation of this legislation.
- **19. SECTION 7.** This legislation shall go into effect immediately upon passage.
- **20. SECTION 8.** All laws in conflict with this legislation are hereby declared null and void.

4) A Bill to Prevent Congress From Influencing the CDC Research Agenda

- 1. WHEREAS, the CDC is an organization filled with medical professionals with
- 2. experience dealing with medical knowledge.
- **3.** WHEREAS, Congress does not have any particular medical knowledge.
- 4. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- **5. SECTION 1**. Congress can pass no measure that bans any research topic or
- **6.** will influence the research agenda for the CDC.
- **7. SECTION 2.** The CDC is the Center for Disease Control and Research.
- 8. SECTION 3. The enforcement of this bill will be overseen by the US Department of Health
- 9. & Human Services.
- **10. SECTION 4.** This will go into effect immediately upon the passing of this bill.
- 11. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

5) A Bill to Require the MMR Vaccination of Schoolchildren

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. All children attending public school are hereby required to be vaccinated
- **2.** for MMR in order to attend public school.
- 3. SECTION 2. Children that are not vaccinated for MMR shall not be allowed to attend
- 4. public school.
 - **A.** Public school shall be defined as any school that is funded primarily by tax dollars as part of the budget.
 - B. Vaccinated shall be defined as having been inoculated against Measles, Mumps, and Rubella.

- **C.** MMR shall be defined as Measles, Mumps, and Rubella.
- 5. SECTION 3. The Department of Education shall be charged with implementation of this
- **6.** legislation. Each child that is being screened for kindergarten shall be asked to provide a full
- 7. history of vaccinations. If the child has not received the MMR vaccination, they shall not be
- **8.** allowed to attend public school.
- SECTION 4. This legislation shall go into effect when kindergarten screening begins for
 school year 2018-2019.
- 11. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

6) A Bill To Reform the Muslim Communities Attire in the Workplace and Fight Religious Inequality

Be it enacted by the representatives here assembled that:

- 1. SECTION 1. The United States Government shall create reforms in all workplace
- 2. dress code to address religious inequality and targeting towards Muslim women and men.
- 3. SECTION 2. The reform in dress code shall go towards allowing equal amounts of religious
- **4.** attire in the workplace
 - **A.** It will allow Muslim women and Men to wear head/body coverings such Hijabs, Burqas, and a Taqiyah.
 - **B.** "Dress code" is defined as the attire employees are permitted to wear at the workplace
- **5. SECTION 3.** The United States department of Labor shall oversee this legislation.
- **6. SECTION 4.** This law shall take effect immediately upon passage.
- 7. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

7) A Resolution to Dispose of Spent Nuclear Fuel Under the Ocean Seabed

- 1. WHEREAS, The United States has no sustainable long-term solution to storage of nuclear
- 2. waste with the closure of Yucca Mountain; and
- 3. WHEREAS, Current methods of nuclear waste storage leave the United States susceptible to
- 4. terrorist attacks; and
- 5. WHEREAS, Sub-seabed disposal of spent nuclear fuel has been tested and deemed safe; and
- 6. WHEREAS, A sustainable solution to store nuclear waste such as sub-seabed disposal
- 7. removes a critical barrier to support for and commercialization of nuclear energy; and
- **8.** WHEREAS, Nuclear energy is a clean energy source that is increasingly necessary in the
- 9. face of accelerating climate change; and
- 10. WHEREAS, A sub-seabed disposal strategy would create thousands of jobs through
- 11. innovation of spinoff technologies such as autonomous underwater vehicles; now, therefore,
- 12. be it **RESOLVED**, By the Congress here assembled that the United States Department of
- 13. Energy should increase research and development on sub-seabed disposal of nuclear waste.

8) A Bill to Defund Sanctuary Cities

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. All federal funding directed towards cities and counties whose law
- 2. enforcement agencies fail to comply with established federal immigration law shall
- **3.** cease immediately.
- **4. SECTION 2.** Federal funding shall be defined as any funds allocated directly by
- 5. Congress, or given by a federal agency to a city or county. Federal immigration law
- **6.** will be enforced by the DHS, ICE and USBP.
- 7. **SECTION 3.** The Department of the Homeland Security (DHS) shall work in

- 8. conjunction with the Department of the Treasury (DOT) to implement every aspect of
- **9.** this bill.
 - **A.** The DHS and DOT will be responsible for identifying the cities and counties not in compliance with established federal immigration law.
- **10. SECTION 4.** This will go into effect immediately after passage.
- 11. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

9) A Bill to Allow for Physician Assisted Death

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- **2. SECTION 1.** Physician assisted death ought to be legalized.
- **3. SECTION 2.** The procedure and conditions to apply this shall be as follows:
 - **A.** The patient must voluntarily express their wish to die. This must occur without any prompting on the part of the physicians or those visiting the patient.
 - **B.** The patient must make a request for medication for the purpose of ending their life.
 - **C.** It must be determined by two independent physiatrists that the patient is aware and independently able to make such a decision.
 - **D.** The patient must be able to administer the life-ending medication to themselves.
- **4. SECTION 3.** If the conditions in Section 2 are met, the attending physician may prescribe medication in a quantity that will end the patient's life.
- **5. SECTION 4.** This bill shall go into effect July 1, 2018
- **6. SECTION 5.** This bill shall be overseen by the Department of Health and Human Services.
- 7. **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void. *Introduced by the NSDA*

10) A Bill to Withdraw From the North American Free Trade Agreement

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1**. The United States is hereby withdrawn from the North American Free Trade
- 2. Agreement. All regulations related to NAFTA enforcement are considered null and void.
 - **A.** United States-based companies which have manufacturing facilities in Mexico or Canada which fail to repatriate by the deadline listed in Section 2 shall have be taxed at a rate of 40% on all goods produced in said facilities.
- 3. SECTION 2. By November 1, 2020, the United States will negotiate a new agreement with
- 4. the governments of Mexico and Canada related to international economic development.
- 5. SECTION 3. The United States Trade Representative shall have responsibility for
- **6.** negotiating the new trade agreements. If no agreement can be reached by the deadline
- 7. stipulated in Section 2, then all imports from each country shall be subject to a 15% tariff.
- **8. SECTION 4.** This shall take effect sixty days after passage.
- **9. SECTION 5.** All laws in conflict with this legislation are hereby declared null and void. *Introduced by the NSDA*

11) A Bill to Stop Businesses From Discriminating Against Minorities

- 1. Whereas, it is in the interest of the government formed by the people to protect the people,
- 2. And whereas, it is the fundamental duty of the governing body to protect
- **3.** BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 4. **SECTION 1.** Businesses cannot refuse service on the grounds of: gender, sexual orientation,
- **5.** race, or other protected status
- **6. SECTION 2.** 'Protected status' being any minority not mentioned in the section 1
- 7. **SECTION 3.** A new enforcement mechanism will be created to ensure the protection of
- **8.** minorities.
- **9. SECTION 4.** Within the next sixteen months.
- 10. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
