1) A Resolution to Override the FCC

- 1. WHEREAS, there are no legal protections requiring net neutrality and,
- 2. WHEREAS, since 2005, internet service providers (ISPs) have been pressured to
- 3. respect net neutrality by previous administrations and,
- 4. WHEREAS, the Federal Communications Commission is under the jurisdiction of
- 5. the Telecommunications Act of 1996 and,
- 6. WHEREAS, the FCC is set to vote on the matter of net neutrality around December
- 7. 14th; now therefore be it
- 8. RESOLVED, By the Congress here assembled work to enforce net neutrality
- 9. regulations even if the FCC were to repeal such policies.

- 4. WHEREAS, a majority of countries have exempt the cash winnings and medals to be
- 5. treated as income; now therefore be it
- 6. **RESOLVED**, By the Congress here assembled work to propose appropriate
- 7. legislation to amend the Internal Revenue Code of 1986 to eliminate the tax on
- 8. Olympic medals won by United States athletes.

- 6. and, WHEREAS, the United States recognizes that aside from the humanitarian
- 7. implications of the crisis, such acts of genocide destabilize the region and may spur
- **8.** future threats national security; now
- 9. therefore be it **RESOLVED**, By the Congress here assembled work to authorize the
- 10. President to use military force to end the ethnic cleansing of the Rohingya in Burma.

- 4. curtail the investigation of activities of Gen. Michael Flynn and,
- 5. WHEREAS, Mr. Trump sought to use his authority to hinder and cause termination
- 6. of a federal investigation; now therefore be it
- 7. **RESOLVED**, By the Congress here assembled work to impeach, put on trial, and
- 8. remove from office the 45th President of the United States, Donald J. Trump.

6) A Bill to Broaden the Financial Spectrum of the Pell Grant Program

1. Be it enacted by the representatives here assembled that:

- 2. SECTION 1. The United States Government will double the annual award maximum
- 3. and double the expected family contribution eligibility of the Pell Grant program in
- 4. order to provide the subsidy to a broader range of students attending college.
- 5. The broadening of the spectrum will go towards providing grants for families on a
- 6. broader income level.
 - A. Define broadening as the action to expand and encompass more people.
 - **B.** Define spectrum as a range, normally used to classify something that can be placed 8. between two broad points.
- 7. SECTION 3. The United States Department of Education shall oversee this
- 8. legislation.

9. SECTION 4. This law shall take effect immediately upon passage.

10. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

7) A Resolution to Grant Statehood to Puerto Rico

- 1. WHEREAS, Puerto Rico has voted several times in favor of attaining statehood; and
- 2. WHEREAS, Puerto Rico has adopted a territorial constitution which was approved by the
- 3. U.S. Congress in 1951 as "not repugnant" to the U.S. Constitution and is the functional
- 4. equivalent of a valid state constitution; and
- 5. WHEREAS, A U.S. Senate committee has heard testimony on Puerto Rico's 2012 statehood
- 6. referendum vote and acknowledged that the majority of Puerto Rican people had voted in
- 7. favor of statehood; and
- 8. WHEREAS, Puerto Rican citizens are already automatically granted full U.S. Citizenship;
- 9. now, therefore, be it

10. RESOLVED, That the Student Congress here assembled shall hereby grant full statehood to

11. the U.S. Territory Puerto Rico.

8) A Resolution Regarding Oil Subsidies

- **1.** BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2. WHEREAS, the United States reliance on fossil fuels will become more problematic as
- 3. current reserves become depleted, and,
- 4. WHEREAS, the development of electric cars presents an opportunity to decrease
- 5. reliance on fossil fuels, and,
- 6. WHEREAS, the fossil fuel industries within the United States currently receive
- 7. substantial subsidies from the United States government, and,
- 8. WHEREAS, the United States must continue to promote environmentally sustainable
- 9. innovation, therefore, be it
- 10. RESOLVED, by the congress here assembled that 50% of the subsidies currently granted

11. to the fossil fuel industry to the electric car producing divisions of automobile

12. manufacturers by the year 2020.

9) A Bill to Permit Immigration Agents in Schools

- **1.** BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. SECTION 1. All public and charter schools in the United States which receive federal Title I
- **3.** funding are required to:
 - A. Provide access to school property to Immigration and Customs Enforcement officials upon request.
 - B. Provide access to students for the purpose of interview, with school officials acting in loco parentis.
 - C. Provide student records and personal information to Immigration and Customs Enforcement officials upon request.
- 4. SECTION 2. Such disclosures of information shall not constitute a violation of the Federal
- 5. Educational Records Privacy Act.
- 6. SECTION 3. Immigration and Customs Enforcement will inform the Department of
- 7. Education as to when a school or district refuses to comply with the terms of Section 1. Any
- 8. violation of Section 1 may result in the withholding of all Title 1 funding for said school or
- 9. district until such time as they are in compliance.
- 10. SECTION 4. This shall take effect upon passage.

11. SECTION 5. All laws in conflict with this legislation are hereby declared null and void. *Introduced for Congressional Debate by NSDA*

10) A Bill to Increase Public Investment in Geothermal Energy

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- **SECTION 1**. \$500 million shall be allocated toward the subsidization of the US geothermal energy industry.
- **SECTION 2**. Geothermal energy shall be defined as energy derived and generated from heat stored in the Earth.
- **SECTION 3.** The U.S. Department of Energy shall be charged with the implementation of this legislation.
 - **A.** Funding for this legislation shall come from an increase in the federal gas tax of 2 cents per gallon.
 - B. All additional or leftover funds shall be redirected to the National Highway Trust Fund.
- **SECTION 4.** This legislation shall go into effect FY 2019.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
