1) A Bill to Implement Adequate Food Recalls by the F.D.A.

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1.** The United States Government will implement the adequate food recalls
- 2. carried out by The Food and Drug Administration in order to remove contaminated food
- **3.** from store shelves.
- 4. **SECTION 2.** The recalls will require the F.D.A to evaluate food-borne hazards in a
- **5.** timely manner and require that companies initiate recalls when hazards are detected.
 - **A.** Define food-borne hazards as illness from consuming food contaminated with bacteria or viruses.
 - **B.** Define timely manner as the period in which food is recalled with as little exposure to consumers as possible.
 - **C.** Define recalls as the process of removing contaminated or inadequate to sell foods from store shelves and consumers.
- **6. SECTION 3.** The United States Department of Health and Human Services shall
- 7. oversee this legislation.
- 8. All companies failing to remove contaminated foods in a forty day period will be fined
- **9.** \$10,000 a day until recalls have been followed through.
- **10. SECTION 4.** This law shall take effect 90 days after passage.
- 11. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

2) A Bill to Legalize Marijuana

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. Marijuana is hereby legal for use as a recreational drug and legal for use as
- 2. a medicinal drug. It is hereby legal to sell Marijuana for those who possess a permit to do
- 3. so from the FDA. Marijuana shall be taxed at an additional rate of 10%. It is hereby legal
- **4.** to grow Marijuana for those who possess a permit from the FDA.
- 5. SECTION 2. Marijuana shall be defined as a drug derived from hemp that possesses
- **6.** psychoactive properties.
- 7. **SECTION 3.** Marijuana is legal to use recreationally for individuals older than 21. It is
- **8.** hereby legal to sell Marijuana for those who possess a permit to do so from the FDA.
- 9. Marijuana shall be taxed at an additional rate of 10%. It is hereby legal to grow
- **10.** Marijuana for those who possess a permit from the FDA.
- 11. SECTION 4. The Food and Drug Administration and the Justice Department shall
- 12. oversee the enforcement of this bill.
 - **A.** The Food and Drug Administration must go through the approval process for Marijuana. The Food and Drug Administration shall also be responsible for issuing permits to sell and grow Marijuana.
 - **B.** The Justice Department shall clear all charges and cease all punishment for individuals who have been prosecuted or are being prosecuted for the possession or usage of Marijuana.
- **13. SECTION 5.** This bill shall be implemented on January 1st, 2019.
- **14. SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

3) A Bill to Reduce the National Drinking Age to 18

- 1. Whereas, the legal drinking age was formerly up to the state governments to determine, and
- 2. Whereas, many states had a legal drinking age of 18 or 19 until 1984 when states were
- 3. compelled by the National Minimum Drinking Age Act to adopt 21 as the legal drinking age,
- 4. and Whereas, 18 is the age you become an adult and can legally vote and fight for
- 5. our country in the military,
- **6.** BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 7. Section 1. The United States will repeal the National Minimum Drinking Age Act of 1984.
- **8.** Section **2.** The bureau of Alcohol, Tobacco, Firearms and explosives shall
- **9.** oversee the implementation of this bill.
- **10. Section 3.** This legislation shall go into effect immediately.
- 11. Section 4. All laws in conflict with this legislation are hereby declared null and void.

4) A Bill to Mandate Schools to Offer Computer Science Courses

- 1. WHEREAS many schools will adopt online courses to teach students
- 2. computer science rather than in a physical classroom environment and
- 3. WHEREAS teaching through online programs allows schools with limited budgets to
- 4. offer these courses in their curriculum at minimal cost
- 5. BE IT ENACTED BY THE STUDENT CONGRESS ASSEMBLED HERE THAT:
- **6. SECTION 1.** All public high schools shall be required to offer computer science
- 7. courses to all students.
- **8. SECTION 2.** Courses public high schools can offer, but are not limited to:

- **A.** Introduction to Computer Science and Interactive Programming
- **B.** Web Development Basics: HTML, CSS, JAVASCRIPT
- C. Effective Programming with Algorithms through Java, C#, or C++
- **D.** Foundations of Game Development and Game Theory
- 9. SECTION 3. If schools lack the resources to provide these courses, additional
- 10. funding will come from the United States Department of Education
- 11. SECTION 4. This legislation shall go into effect for all public high schools before
- 12. the beginning of the 2018-2019 school year.
- 13. SECTION 5. The United States Department of Education will oversee the implementation of
- **14.** this legislation
- **15. SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

5) A RESOLUTION TO MEDIATE IN INDO-PAKISTANI AFFAIRS

- 1. WHEREAS, India and Pakistan are closer to the brink of nuclear deployment than any point
- 2. in the last 50 years and,
- **3.** WHEREAS, the attacks on the Indian military base at Uri were intended to get the attention
- 4. of the international community and,
- 5. WHEREAS, the current administration has yet to choose a side in the Indo-Pakistani feud,
- **6.** now; therefore be it
- 7. **RESOLVED**, By the Congress here assembled work to insert itself into the conflict between
- 8. India and Pakistan by pressuring India to make an agreement with Pakistan on the disputed
- 9. territory of Kashmir

6) A Bill to Abolish the Subminimum Wage

- 1. **SECTION 1:** The subminimum wage shall be raised to the current federal minimum wage.
- 2. SECTION 1A: Whenever the federal minimum wage increases, the subminimum wage shall
- 3. also be increased to ensure the equal amount as the minimum wage.
- **4. SECTION 2:** The *subminimum wage* shall be defined as the employment of student-learners,
- **5.** tipped workers, or disabled workers at below the minimum wage.
- **6. SECTION 3:** The Department of Labor shall oversee this of legislation.
- 7. **SECTION 4:** This legislation shall be made effective FY 2019; April 1, 2018.
- **8. SECTION 5:** All laws in conflict with this bill are hereby declared null and void.

7) A BILL TO RESCIND THE GLOBAL GAG RULE

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1: International health funding shall be provided to qualified
- 2. organizations with no limitations as to the discussion of contraception abortion.
- 3. SECTION 2: This legislation shall not be considered a repeal of any rule prohibiting
- **4.** U.S. finds from being used directly to directly provide abortion or abortion services.
- **5. SECTION 3:** The US Agency for International Development shall oversee the
- **6.** implementation of this legislation.
- 7. **SECTION 4:** This legislation shall be made effective immediately upon passage.
- **8. SECTION 5:** All laws in conflict with this legislation are hereby declared null and void.

8) A Bill to Relocate the U.S. Embassy in Israel

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. **SECTION 1:** The Embassy of the United States to Israel shall hereby relocate from
- **3.** Jerusalem to Tel-Aviv.
- **4. SECTION 2:** U.S. Military personnel shall be stationed in Jerusalem to supervise the transition.
- 5. SECTION 3: The Department of State and Department of Defense shall oversee this
- **6.** of legislation.
- 7. **SECTION 4:** This legislation shall be made effective May 14, 2018.
- **8. SECTION 5:** All laws in conflict with this bill are hereby declared null and void.

9) A Bill to Means Test Social Security to Ensure Fiscal Solvency

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1.** Future retirees who earn more than \$110,000 per year during ten or
- 2. more years of their career will be ineligible for Social Security benefits upon retiring.
- 3. SECTION 2. "Future retirees" refers to those who begin eligibility for Social
- **4.** Security after the implementation date of this legislation.
- **5. SECTION 3.** The Social Security Administration will oversee the implementation of
- **6.** this legislation.
- 7. **SECTION 4.** This legislation shall take effect on October 1, 2020.
- **8.** All laws in conflict with this legislation are hereby declared null and void.

10) A Bill to Grant Amnesty to Current Undocumented Residents BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1.** Amnesty shall be granted over a ten-year period beginning March 1,
- 2. 2018 and ending on December 31, 2028 to all residents who entered the United States
- **3.** illegally prior to its enforcement date.
- 4. SECTION 2. Residents must prove that they have not committed repeated serious
- 5. felony offenses. No other standards or requirements may be implemented except
- **6.** those required for clerical purposes.
- 7. SECTION 3. Residents granted amnesty through this bill may begin voting in the
- **8.** Presidential election following their amnesty and in every election thereafter. State
- 9. and city legislatures may not abridge this right.
- **10. SECTION 3.** This bill shall go into effect March 1, 2018.
- 11. SECTION 4. The Department of Homeland Security shall implement this bill.
- **12. SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

11) A Bill to Make the Electoral College More Representative

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. The Secretary shall withhold 15% of the amount required to be
- 2. apportioned to any State for the funding of research in public universities on the first
- 3. day of each fiscal year in which the votes of electors in the State are not divided as
- **4.** outlined in Section 2.
- **5. SECTION 2.** In each Presidential election, States shall total the number of votes cast for

- **6.** each candidate in their State.
 - **A.** Two electoral votes shall be attributed to the candidate which has won the popular vote in the state.
 - **B.** The remaining electoral votes shall be divided proportionally to the popular vote in the state.
- 7. SECTION 3. This bill shall go into effect for the 2020 Presidential Election.
- **8. SECTION 4.** This bill shall be overseen by the Office of the Federal Register.
- **9.** All laws in conflict with this legislation are hereby declared null and void.

12) The Infrastructure Improvement Act of 2017

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. **SECTION 1.** All Interstate highway improvement needs, as determined by the Federal
- 2. Highway Administration and the Interstate Maintenance program, shall be put out to bid for
- **3.** private contractors who will complete the work at their own expense.
- 4. SECTION 2. Such private contractors may be permitted to charge a toll for travel upon the
- 5. segment of highway which they maintain. They will retain toll rights for a period of ten
- **6.** years. The private contractor shall be permitted to set the price of the toll at a level by which
- 7. they estimate they will recover their costs within seven years.
- **8. SECTION 3**. The Department of Transportation shall oversee the procurement of private
- 9. contractors to maintain the interstate highway system. The portion of the federal tax on
- **10.** gasoline intended for highway maintenance shall be removed for a period of 10 years.
- **11. SECTION 4.** This shall take effect on October 1, 2018.
- 12. All laws in conflict with this legislation are hereby declared null and void.

13) A Bill to Increase Public Investment in Geothermal Energy

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. \$500 million shall be allocated toward the subsidization of the US
- **2.** geothermal energy industry.
- 3. SECTION 2. Geothermal energy shall be defined as energy derived and generated
- **4.** from heat stored in the Earth.
- **5. SECTION 3.** The U.S. Department of Energy shall be charged with the
- **6.** implementation of this legislation. Funding for this legislation shall come from an increase in
- 7. the federal gas tax of 2 cents per gallon.
- **8.** All additional or leftover funds shall be redirected to the National Highway Trust Fund.
- **9. SECTION 4.** This legislation shall go into effect FY 2019.
- **10. SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

14) The Medicare for More Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION 1. A public option for health insurance shall be offered nationwide in
- 2. individual market exchanges.
- 3. SECTION 2. A public option shall be defined as a publicly funded health insurance
- **4.** option for those under 65 that will compete against private insurers.
- 5. SECTION 3. The Department of Health and Human Services shall be charged with
- **6.** implementation of this legislation.
 - **A.** The public option shall be funded by a 0.03% financial transaction tax on high

frequency trading.

- **B.** The Internal Revenue Service, in conjunction with the Securities Exchange committee, shall be charged with implementing the financial transaction tax.
- 7. **SECTION 4.** This legislation shall go into effect at the start of FY 2019.
- 8. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
